WRJW-AM GENERAL CONTEST RULES

Note: The following contest rules apply in our day-to-day contests. Any special contests conducted on WRJW Radio, Picayune, may contain additions or modifications to these rules. Rules for special contests will be available at the radio station during those events.

- 1. Contests on WRJW are designed with fairness to all and we do ask that you keep these policies in mind.
- 2. The only phone number used for WRJW contests is 798-4836.
- 3. Winners of non-cash prizes will have three (3) working days to claim their prize.
- 4. Winners of cash prizes have thirty (30) calendar days to claim their prize.
- 5. WRJW limits all cash prize winners to once per household in any thirty (30) day period.
- 6. WRJW limits all non-cash prize winners to once per household in any fourteen (14) day period.
- 7. Contest winners must provide their social security number and another form of identification and are required to sign a release form prior to claiming the prize offered.
- 8. The decisions of the judges in all WRJW contests are final. Judges include air staff conducting on-air giveaways.
- 9. WRJW reserves the right to alter and/or terminate a contest at any time without prior notification to contestants.
- 10. WRJW makes no warranties with respect to the prize being offered.
- 11. Unless otherwise stated, all prizes are nonrefundable, nontransferable and have no cash value.
- 12. Unless otherwise stated, contestant must be listening to win. Contestant may not represent another party.
- 13. No purchase necessary.
- 14. The employees of WRJW / PEARL RIVER COMMUNICATIONS, INC. and their families, plus the representatives, sponsors and their families actively involved in any contest on WRJW are ineligible.
